

# City of Detroit Brownfield Redevelopment Authority – Special Meeting Wednesday, April 15, 2020 at 2:00 PM

On March 23, 2020, Governor Whitmer issued Executive Order 2020-21, prohibiting in-person work that is not necessary to sustain or protect life. As a result, all meetings of the Detroit Brownfield Redevelopment Authority (DBRA) will be held by electronic means until restrictions on in-person gatherings have been lifted by the Governor.

All meetings will be held consistent with Executive Order 2020-15 and will provide a means for the community to participate. Meetings will be posted in accordance with the Open Meetings Act, as modified by Executive Order 2020-15.
