

# City of Detroit Brownfield Redevelopment Authority-Community Advisory Committee – Regular Meeting Wednesday, June 10, 2020 at 5:30 PM

On March 23, 2020, Governor Whitmer issued Executive Order 2020-21, prohibiting in-person work that is not necessary to sustain or protect life. As a result, all meetings of the Detroit Brownfield Redevelopment Authority-Community Advisory Committee (DBRA-CAC) will be held by electronic means until restrictions on in-person gatherings have been lifted by the Governor.
