

# CITY OF DETROIT DOWNTOWN DEVELOPMENT AUTHORITY FINANCE COMMITTEE MEETING TUESDAY, SEPTEMBER 8, 2020 AT 10:00 AM

On March 23, 2020, Governor Whitmer issued Executive Order 2020-21, prohibiting in-person work that is not necessary to sustain or protect life.
